**By Email:** A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to IEBnominations@aec.gov.au PLEASE NOTE:

- 1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

#### **Candidate Statements**

Candidates may submit a statement, as a Microsoft word document, not exceeding 250 words. A passport style photo may also be submitted with the candidate statement for publication. Statements **must not** contain any derogatory or inappropriate language and must be received by the Returning Officer **not later** than 5:00pm Australian Eastern Standard Time (AEST) **on** 17/02/2023.

**Scrutineer Appointment** A candidate in any election shall be entitled to appoint, by notice in writing to the Returning Officer, another person to act at his/her own expense as a scrutineer on his/her behalf.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
